Report for funds disbursed to students

Report funds disbursed to students per the Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act-March 27,2020

The requirements for these funds must complete the below criteria.

An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the applicable amount of funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to Students. **Choffin Career & Technical Center acknowledged the Certification and Agreement on July 23, 2020.**

The total amount of funds that the institution will receive or has received from the Department of Education pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students. **Choffin Career & Technical Center has been awarded HEERF I funds in the amount of \$93,251.00, HEERF II funds in the amount of \$93,251.00, and HEERF III funds in the amount of \$268,587.00.**

The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the initial report and every calendar quarter thereafter). **Choffin Career & Technical Center disbursed \$93,251.00 to 53 students as of 8/13/2020.**

The total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students Section 18004(a)(1) of the CARES Act. **Choffin disbursed Emergency Financial Aid to 53 students. All eligible students were disbursed aid per allocation requirements, as outlined under Section 18004 (a)(1).**

The total pool of eligible students to apply for emergency aid from the first round of CARES Act funding was 53.
